### A. NEOLA policy updates

**Background:** There are multiple suggested updates to our Board Policies. The recommendation is to accept the updates to policies #0131.1, #2340, #5320, #5330, #5330.01, #5350, #5460, #8320, #8500, and #8510. It is recommended that we rescind #1430 and #8640. It is also recommended that we reject #3430 and #4430. #1430, #3430 and #4430 are related to the new ESTA guidelines and it is not necessary to have a policy. #8640 is now included in the updates #2340 and so is not needed any longer.

# B. Approve Waiver option for PE

**Background:** The State allows districts to offer a waiver for marching band students to bypass taking a PE class in high school. By offering this waiver we give our students more flexibility to choose an elective class that better matches their interests. It also frees up spots in our PE classes for other students who would like to take those classes as an elective. Students will need to take marching band for at least two years to qualify for the waiver, but they may still take PE if they wish to. The waiver is just an option, not a requirement.

Motion by TenBrink, seconded by DeJong, to approve the PE waiver option for marching band students as presented.

#### C. Filter First Install

**Background:** The Michigan Department of Environment, Great Lakes and Energy (EGLE) helped create legislation that requires schools and child care centers to meet water quality standards. Under the guidelines, water fixtures in a school that are used for consumption (drinking or food preparation) must be filtered at the point of use. This is called the Filter First initiative. To meet this requirement, after seeking bids from 4 companies, it is recommended that we use DHE plumbing at a total project cost of \$180,981.11.

Motion by Ramey, seconded by Hendricks, to approve using DHE for the plumbing work needed to meet the State's Filter First requirements as presented. Motion carried.

# D. Resolution to approve OAISD 2025-2026 Budget for Ottawa Area Intermediate School District General Fund Budget Resolution

**Background:** Each local district is required to pass a resolution approving the ISD's General Fund Budget. This is an annual event. In accordance with Section 380.624 of the Revised School Code, this Board must now adopt a resolution expressing its support or disapproval of the proposed ISD budget, and must submit to the ISD Board any specific objections and/or proposed changes to the budget prior to June 1, 2025.

Motion by DeJong, seconded by Harris, to approve the Ottawa Area Intermediate School District General Fund Budget Resolution as presented. Motion carried.

F. Approve changing the name of the New Options High School Program Background: Our alternative high school program has a reputation as more of a credit recovery program, but the vision is for this to be a diploma granting program. We need to make sure that students who are seeking a different type of education, know that our alternative high school is a great program for earning their diploma. The name we would like to use for the rebranding is the Allendale Virtual Academy (AVA). This is a program that offers great flexibility in an online learning format.

Motion by DeJong, seconded by TenBrink, to approve changing the name of New Options High School to the Allendale Virtual Academy as presented. Motion carried.
